GROUPS

PAYMENT

- Rates are expressed in **US dollars**.
- If paying in Argentine pesos, the "selling exchange rate" is the one to be consider at the moment of processing the payment.
- A deposit of **30%** of the value of the whole reservation is required to confirm the reservation. All reservations are tentative until the deposit has been received.
- All payments are non-refundable, even in cases of force majeure.
- All existing payments for reservations that need to be cancelled within a valid cancellation term, will be consider as credit for future reservations, as they are non-refundable.
- Credit cards are accepted (**Visa, MasterCard y American Express**)
- **To apply for the VAT refund ("Devolución del IVA")**, you must comply with Decree 1.043 / 2016 and its conditions: be a non-resident tourist in Argentina who stays in the country for less than 90 days. Payment of your stay must be made with credit card issued outside Argentina, or via wire transfer from abroad. If payment is coming through an Argentine travel agency, the agency needs to be registered at the National Tourism Secretary, and will be responsible for overseeing and verifying the payment process. It is necessary to send scanned copies of the guests' passports beforehand, and to present original passports during the check-in process.
